AND WHEREAS the City of Morden has completed a feasibility study to divert water from Pembina River to the Dead Horse creek to increase the raw water supply from Lake Minnewasta, and for drought resiliency in partnership with PVWD and RM of Stanley, which shows that project is feasible;

AND WHEREAS this project may be eligible for technical and financial assistance from Manitoba Water Services Board (MWSB) for preparing functional design and Environment Act proposal;

THEREFORE BE IT RESOLVED that Council of the City of Morden requests Manitoba Water Services Board to provide financial and technical assistance for preparing functional design and EAP and any other required investigations related to Pembina River to Dead Horse Creek Water Diversion Project.
